Exclusively for Students of Company Secretaryship

IGNOU in collaboration with the Institute of Company Secretaries of India (ICSI) launched specialised Commerce Programmes **exclusively** for the students pursuing the Company Secretaryship course. The Scheme facilitates the students of CS to obtain the B.Com (CA&A) / M.Com (BP&CG) Degree including the period of study at ICSI. Once the student passes the specified courses from IGNOU, the credit transfer is given to the courses completed from ICSI.

B.Com (CA & A): Students who have already **passed ICSI Intermediate / Executive** programme before joining the IGNOU can obtain the Degree **in a minimum period of one year**. Students who have passed Foundation programme of ICSI can obtain the Degree **within a minimum period of 2 years** with the condition that the total period of study including one year at IGNOU should not be less than 3 years from the date of registration in foundation course of ICSI.

M.Com (BP & CG): Students, who have already **passed ICSI Programme (Final)**, can complete the Degree within a **minimum period of one year** subject to minimum of two years from completion of graduation.
