Based on the merit order position in the result declared for the B.Ed., Entrance Test held on 20.09.2015, you have been provisionally selected for the B.Ed., admission to January 2016 session. Confirmation of admission is subject to verification of all original documents pertaining to your academic qualifications. According to your Merit Rank/Marks position, category (SC/ST/PH/ OBC (NCL)/KM/WW/General), you have been called for the admission counselling. The Annual income of the candidates under OBC (Non Creamy Layer) should not exceed 6.00 lakhs per annum. The date and time of your turn for admission counselling at IGNOU Regional Centre, Sikkandar Chavadi, Alanganallur Road, Madurai-625 018 is mentioned in the address label pasted at the bottom of this letter. You are advised to be present at Regional Centre, Madurai at least an hour before the start of counselling as per the time slot specified in the address label and you will have to wait for your turn for counselling. If you are not present on the date & time of counselling, it will be presumed that you are NOT interested in accepting the offer/joining IGNOU B.Ed., and hence this offer sent to you will be cancelled without further notice.

You are also requested to bring the Programme Fee of Rs.20,000/- in the form of a Demand Draft drawn in favour of "IGNOU" payable at Madurai from any one of the Nationalized Banks. (This is a pre-revised Programme Fee as Programme Fee is under revision.)

You must bring **ALL THE DOCUMENTS IN ORIGINAL** as well as the self attested copies of documents as listed in **CHECK LIST** for verification. In case you fail to bring the documents as mentioned above, on the specified date/time as indicated in the address label and fail to provide required evidences for qualifications and category / community / caste etc., your candidature will be summarily rejected. The University will not entertain any further query in this regard under any circumstances. Please read the information and guidelines thoroughly and check all the documents before coming to the Regional Centre. Details of documents to be submitted are printed on the reverse side of the Check-list.

"This offer of admission is provisional and is based on the documents in respect of qualification and other eligible criteria submitted by you along with the application form. If at a later stage, it is found that the document(s) submitted by you is/are false, your admission shall stand cancelled forthwith and no fee refund will be admissible in the event of such cancellation of admission."

The B.Ed., programme is activated only at **Sri Ramakrishna Mission Vidyalaya**, **College of Education**, **Coimbatore (PSC 2516) under Madurai region**. The allotment of Programme Study Centre (PSC) would be based on the availability of seats and in accordance with the reservation policy of the University, Government of India.

In respect of NCTE qualification in teacher education programme acquired through face-to-face mode, the candidates are required to produce the authentication by the Certificate Issuing Authorities stating that "the Certificate awarded to the candidate is the NCTE recognized and approved teacher education porgramme through face to face mode. In case of non-existence of the Certificate Issuing Authorities at present, a certificate may be obtained from NCTE recognizing that course as a teacher education programme through face to face mode. Please note that those candidates who received the Master's Degree without the Bachelor Degree are NOT ELIGIBLE for Admission to IGNOU's B.Ed. Programme.

Permission for practical work (work centre) including Internship should be obtained only from Secondary / Higher /Senior Secondary school and hence, the certificate obtained from **Middle/Primary / Nursery School is not permitted.**

- ❖ <u>Tie Cases</u>:- In respect of the candidates having scored same marks in B.Ed., Entrance Test, the tie will be resolved during the admission counselling. Therefore, you are requested to bring the documents namely (i) UG and PG Mark Sheet for all the years including Provisional / Convocation Certificate. It may be noted that there are 11 candidates scored 63 marks under OBC (NCL) Category in B.Ed., Entrance Test, out of which only 2 candidates will be selected by resolving the Tie. Similarly, under SC category there are three candidates scored 63 marks out of which 2 candidates will be selected by resolving the Tie Cases. <u>Therefore, in respect of Tie Cases</u>, the selection is subject to resolving the Tie and this offer of admission does not give you any right to claim admission for B.Ed., 2016 admission and decision of the University in resolving the Tie and selection of candidate is final.
- In the event of your candidature not being considered for admission, this offer stands cancelled automatically and all the documents submitted by you will be retained by the University for records, except the Demand Draft.
